Subject: Clerk / RFO's Report — Budget monitoring to 19th November 2025

1. Purpose of Report

The purpose of this report is to provide a clear monitoring position to Full Council as to the nature of our finances. The data is accurate to Wednesday 19th November 2025.

2. Executive summary

- 1) At 19th November 2025 the council is operating within the approved budget.

 - o general reserve £23,968.75 (25% of precept).
